* Member Companies are defined as the Companies holding membership of AIRIA. Companies applying under member rates need to submit the membership number along with space booking.

** They must have been members of the association in good standing for last 3 years and with no dues outstanding at the time of application. New members joining will need to pay 3 years subscription to avail this benefit.

*** Built up space includes Fascia, Carpeting, 3 Spot lights, 1 No. system Table, 3 Chairs, Glass top round table 1 no. Glass / wooden shelves 2 nos., Outlet socket 1 No. and Waste Paper Basket, with every 9 sqm. module. However, electricity consumption charges are to be paid separately.

Notes

- The prospective Exhibitor must apply on the Space booking contract form-for participation in India Rubber Expo, 2022-indicating requirement for built up and/or raw space. The Organisers will do allocation of space. Allotment will be done on "first come - first serve" basis strictly subject to receipt of advance and payments within the above categories / defined rules. The decision of Organiser on space allotment is final.
 - The Exhibition will be spread in and around Hall Nos. A4aGF, A4bGF & A5GF at Pragati Maidan, New Delhi. Exhibition halls may change, for time-being, they are as above.
 - Domestic Exhibitors should pay in Indian Rupees by Demand Draft favouring All India Rubber Industries Associations as per schedule. Rental includes passes for staff manning stands during the Fair as per the eligibility and one free entry in the Fair Catalogue.
 - Filling Up of Forms: It is mandatory to fill the form completely. Incomplete forms will not be entertained. Do not leave any items blank. In case of not relevant please write NA (Not Applicable).
 - The Organiser reserves the right to reallocate space, change the layout, change the stand nos., add or delete corridors in Space Plans that may affect some exhibitors stand orientations. The Organiser's decision shall be final. The Organiser reserves the right to turn down the application for participation, or even deny participation to exhibitors already confirmed. The Exhibitor shall not organise any concurrent shows outside of India Rubber Expo 2022 in New Delhi.
 - The Contract: The Exhibitor enters into a contract upon submission of this document. The Company (prospective exhibitor) agrees to participate at INDIA RUBBER EXPO 2022 and to abide by the rules and regulations & bye- laws to the Exhibitor, before the exhibition. Upon any breach of contract by the Exhibitor, the Exhibitor is liable to pay the space rentals in full, to the organizer. None of the exhibits on display or present at the exhibition premises infringe, or is likely to infringe, any patent, trademark, copyright and other intellectual property rights of any party and agree that in the event of any breach, this contract may be terminated by the organisers unilaterally. In such an event, the exhibitors shall indemnify the organisers against all costs, claims, & demands.
- Damage to exhibition venue:** The Exhibitor will be required to make good all damages, (or make payment in lieu thereof) to the fairground facilities/ building etc. incurred during setting up / fair period and/ or dismantling period.

- Use of Display Space:** Without the express written permission of Organizer, Exhibitor may not (i) sublet, subdivide or assign its space, or any part thereof, (ii) purchase multiple booths for the purpose of subletting or assigning to third party, or (iii) permit in its booth any non-exhibiting company representative. In case of failure to comply with this provision; Organizers reserves the right to cancel the participation and forfeit all the payment.

- Electricity:** Exhibitors will intimate their requirement much in advance (at least 3months in advance).
9 a) Temporary Electricity: is the electricity required by exhibitor during construction / dismantling period. This will be charged separately on requirement and duration basis. For more details please contact Secretariat.

- Mezzanine Construction(Subject to approval by the venue provider) :** 20% of the area for Construction of Mezzanine is permitted for stands above 100 sqmts only. Extra rentals at 50% of raw space costings will be charged separately. Details will be mentioned in the Exhibitors Manual .

- Cancellation:** By signing and concluding of this contract, the exhibitor hereby agrees to indemnify the organizer for the losses at the following rates, in case of withdrawal of participation OR reduction of space at a later stage

* From 1st March to 31st July,2021: at 50% of total rentals

* From 1st August 2021 onwards: with the full stand rents.

- Approval for Design of Stand:** The stand design drawings along with to-scale mock-ups, complete with details of exhibits, electricity, water and other installation, in 4 copies, should be submitted for Organiser's approval, latest by 1st December 2021. A penalty of INR 50, 000/- will be levied on drawings received after this date). In case of non-receipt of stand drawings by 20th December, 2021. The Organisers are at liberty to allot the stand to another exhibitor. The Exhibitor is liable to pay for the space rentals in full to the Organiser.

- Sale of Exhibits:** are subject to Government approvals (to be taken by exhibitors and submit the copy to organizers) and fulfilling tax formalities of relevant Government Authorities. Exhibits on display will be allowed to be removed only after the closure of the show.

- Removal of any Exhibit:** during the fair period is prohibited.

- Clearance of Exhibits:** All Exhibits including stand material to be removed by 0800 hrs on 22 January 2022 after closure of Exhibition on 21 January 2022. Organizer will not be responsible for loss / theft of any of the exhibits or penalty by venue authorities if Exhibitors fail to comply with this date.

- Handling of Exhibits Customs and Import Procedures:** The ORGANISER will appoint official clearing and freight forwarding agencies for India Rubber Expo'22 who will assist in handling customs formalities, if required. Exhibitors would have to contact them directly for such assistance. Movement of exhibits in the Fair Grounds by agencies other than the official clearing and forwarding agents is strictly prohibited.

- Duty Free Temporary Importation of Exhibits:** This facility is extended only to Overseas Exhibitors in India Rubber Expo'22 - who have registered by remitting space rent in foreign exchange. If any one or more of the exhibits displayed by the domestic exhibitor is imported, under duty free temporary importation facility, the USD rate will be charged.

- Possession of Stands:**

a) Built Up Space - 18th January 2022, (10.00hrs.)

b) Raw Space - 16th January 2018, 1400hrs

- Stand Completion:** By 1800 hrs on 18th January, 2022 with all exhibits in position.

- Exhibitor Catalogue Entry:** All Confirmed Exhibitors will get a free entry in the IRE 2022 Exhibitor Catalogue. Exhibitors are required to submit the Form, duly filled in, as per schedule.

- Advertisement in the Exhibitor Catalogue:** Rates will be advised at a later date

- Insurance:** Against all ascertainable risks - from transportation to display and removal - should be done by the exhibitors at their cost. Organiser will, in no way, be responsible.

- Security:** While general security will be provided at entry / exit points of the halls on all days; exhibitors are advised to keep security during construction / dismantling days for safeguarding their exhibits.

- Photography:** The Organiser reserves the right to photograph/video shoots any stand/ exhibit for their use.

- Settlement of Dues & Stand Possession:** Any and all expenses chargeable to an exhibitor must be settled before taking possession of the stand. In an event of balance payment, organiser reserves right to refuse possession to any exhibitor.

- Force Majeure:** If the exhibition is abandoned, cancelled or suspended in whole or in part by reasons of natural calamity, war, fire, national emergency, labour dispute, non-availability of exhibition premises or any of the cause not within the control of the organiser, the organiser may, at their own discretion refund the space rental paid by the exhibitor, or part thereof, but shall be under no liability in respect of any action, claim for losses or under obligation to refund space rental or any other expenses borne by exhibitor for participating at the above said event. Disputes, if any, will be settled under the court of Delhi's jurisdiction (Government of India).

- Taxes**:** Taxes will be charged as per the prevalent taxes applicable under the Rule of Government of India during final billing i.e (January,2022).

- All disputes and differences** arising out of it related to these terms and conditions shall be referred to Arbitration under the provisions of Arbitration and Conciliation Act 1996. The Arbitration shall be conducted by sole arbitrator to be appointed by the Organizer. The Arbitration shall be in New Delhi and the cost of arbitration shall be borne by both the parties equally.
